JoinDayo Candidate's Forum

In order to present a fair and balanced opportunity for all candidates, the following rules will be in effect for the Candidate's Forum interviews.

Interviews will be held on April 18, 2010 at the office of Somerset Realty Associates, at 1165 County St., Somerset.

Each candidate should arrive at least ten minutes in advance of your scheduled time.

Interviews are scheduled at forty-five minute intervals.

Due to scheduling constraints, if a candidate is late, the moderator will announce that fact, and the candidate will be allowed to start when he or she arrives, however, the interview will end promptly at the scheduled time. No candidate will be given any additional time beyond the scheduled time.

Each candidate will be given a short introduction by the moderator, to include the candidate's name and the position he or she is seeking. Each candidate will be then be given a series of questions.

There will be one set of questions for Selectman, a second set of questions for School Committee, and a third set of questions for Water & Sewer Board.

Each candidate for a particular position will be asked the same questions, in the same order.

Each candidate will have two minutes to reply to each question. The moderator will interrupt any candidate that exceeds the allotted time.

The questions will not be given out in advance, and each candidate will be hearing the questions for the first time, during the interview.

After all of the questions have been asked, each candidate will be given two minutes to summarize.

The candidates will be interviewed individually, and in no particular order, with no other candidate(s) present.

Each candidate is free to bring one or more supporters, however no more than two may be present in the interview room. Any other supporters will be allowed to view the interview from outside. Each supporter who is outside is welcome to hold one sign. No signs or other campaign materials will be allowed in the interview room.

No applause, comments or other interruptions will be allowed from the audience during the interview. Should anyone violate this rule, the interview will be halted and the individual will be asked to leave. The time taken up while the interruption is being addressed will be deducted from the candidate's allotted time, and the interview will end at the scheduled time.

The presentation that will be shown on JoinDayo.com will be formatted such that each question will be asked once, and each candidate's response will be shown. For the first question, the candidates will be presented in alphabetical order, by last name. For each subsequent question, the order will be shifted.

For example, the order for first question will be Candidate A, Candidate B, Candidate C. For the second question, the order will be Candidate B, Candidate C, Candidate A, Candidate B, and so on.

The final summary will be given in alphabetical order for each position, by candidate last name.

If there are any questions regarding the process, please submit them via email in advance. The question, and the answer, will then be posted on JoinDayo.com for all candidates to view.

No questions from the candidates will be allowed on the day of the interview.

The entire interview will be recorded, however only the candidate's answers will appear on the website.

In the event of any technical problem that is discovered on the day of the interview, the candidate may be asked to answer a particular question again. In the event of any technical problem that is discovered after the interview, the candidate will be invited to come back and answer the affected question(s).
